Dear President Biden:

We, the undersigned organizations, thank you for including support for family caregivers in the Executive Order you issued on April 18. It is important to prioritize action to better recognize, assist, include, support, and engage our nation's family caregivers. We appreciate that your Executive Order takes important steps to do that. While their contributions are invaluable, the challenges caregivers face are many.

Most of us are, have been, or will be a family caregiver or will need help to live independently. This is a nonpartisan and ageless issue. Family caregivers are all ages, races, and ethnicities and cut across all segments of our population. They are the backbone of services and supports in this country, helping older adults, people with disabilities, and veterans live independently in their homes and communities. The physical, emotional, and financial challenges they face in their caregiving roles cannot be overstated, consistent with a recently released [poll](#) on family caregivers.

There is also a significant economic impact, as millions of family caregivers provide [\\$600 billion](#) annually in unpaid care to their loved ones, more than all out-of-pocket spending on health care in the U.S. in 2021. This includes assisting with meal preparation, eating, bathing and dressing, transportation, finding and coordinating services and other supports, managing finances and medications to medical/nursing tasks such as wound care, injections, and tube feedings, and so much more. The assistance they provide helps save taxpayer dollars by helping to delay or prevent more costly nursing home care and unnecessary hospital stays. Six in ten family caregivers are also balancing working with caregiving responsibilities. Family caregivers spend, on average, [26 percent of their income](#) (over \$7,200 annually) on caregiving.

We support last year's release of the 2022 National Strategy to Support Family Caregivers, resulting from the bipartisan RAISE Family Caregivers Act. The strategy's identification of nearly 500 actions to support family caregivers provides an important roadmap on actions that are and will be taken by the Administration, as well as actions that can be taken at the state and local level and by other stakeholders. It is important to turn this National Strategy into meaningful action, including ensuring that federal agencies follow through on their commitments. This is critical to make progress for family caregivers. We appreciate that your Executive Order builds on the strategy and could help a family caregiver caring for a Medicare beneficiary get the information they need, improve inclusion of family caregivers in hospital discharge planning and consider and support them in Hospital at Home Programs, provide support to those caring for loved ones with dementia and support military veteran caregivers, as

well as the paid direct care workforce. We hope you will continue to seize the opportunity to advance policies that would make it easier for family caregivers to find the resources and support they need; help ensure caregivers are appropriately included in their loved one's care, including in Medicare; make it easier to find paid care, including by attracting and retaining a strong paid workforce; and provide financial and other relief, such as through a caregiver tax credit, respite, and workplace flexibility.

We are glad you recognize the importance of family caregivers to our nation, states, communities, and families. During Older Americans Month and the Month of the Military Caregiver, we come together to thank you and urge you and your Administration to continue action to preserve and improve family caregivers' own health and well-being. We look forward to ongoing work with you on this critical issue and ensuring tangible results for family caregivers.
